

Minutes of the Cando City Council

The Cando City Council met Tuesday, July 5, 2022 at 7:00 p.m. at the Towner County Courthouse, for the purpose of reorganization and swear ins of the newly elected officials after the election. Newly elected Mayor Rollie Bjornstad, newly elected Councilors Roger Scott, Todd Klingenberg, and Rod Halverson were present, along with current Councilors Duane Holien, Sig Bjornstad, and Jeremy Olson. Mayor Bjornstad called the meeting to order. Auditor Hoover swore in Rollie Bjornstad as new mayor. Then Mayor Bjornstad administered the Oaths of Office for the newly elected Counselors and Park Board Members. Mayor Bjornstad asked for nominations for President of the Council. Councilor Olson nominated Councilor Bjornstad and Councilor Bjornstad nominated Councilor Olson. Roll call vote resulted in Councilors Scott, Holien, Klingenberg, and Olson voted for Councilor Bjornstad as President of the Council. Mayor Bjornstad asked for nomination for Vice President of the Council. Councilor Holien nominated Councilor Olson. All voted aye.
