

Minutes of the Cando City Council

The Cando City Council met on Tuesday, June 20, 2023, at 7:00 pm at the Towner County Courthouse. Councilors Halverson, Bjornstad, Olson, Klingenberg, Miller and Scott were present, with Mayor Bjornstad presiding.

Motion by Councilor Olson and seconded by Councilor Klingenberg to approve the agenda as written. All voted aye and the motion passed. Motion by Councilor Bjornstad and seconded by Councilor Scott to approve the minutes from the previous meeting as written. All voted aye and the motion passed.

Old Business: Brad Muscha from Moore Engineering provided the council with an update on the Sewer Project. He said that the partnership agreement between the USACE and the City will hopefully be ready to sign in late August. Muscha also told the council that they are beginning to do the preliminary work for the Environmental Assessment, and working on finalizing the exhibits for the easements that are required. He also shared with the council that they are finalizing the Geotechnical Proposals and hope to have them ready for the next meeting.

The Council talked more about the information that Deputy Kennedy presented at the May 16th meeting regarding driving golf carts and low speed vehicles around town.

The houses that are on the Condemnation list were discussed again. Council decided that another letter needs to be sent out to the property owners inviting them to either attend a meeting or submit an update on what their plans are for these properties.

New Business: The council acknowledged the building permits for Alex Puppe, Robert Sitz and Larry & Julie Starr that were approved by the Building Inspector.

The financials for May were reviewed by the Council.

Open Committee: Councilor Klingenberg brought up street signs and asked if there was a policy to deal with them once they become extremely faded. He also inquired about a couple of missing street signs as well.

The roof on the Audi Theater was discussed. After talking about how it, the council decided to get a bid for replacing the roof.

With the next meeting falling on July 4, the Council decided to tentatively cancel it. The next meeting will be on July 18.

Bills for Approval: A motion was made by Councilor Olson and seconded by Councilor Bjornstad to pay the bills. All voted aye and the motion passed.
